Z Car Association of Richmond (ZCAR)

Terms of Participation and Release of Liability

I HEREBY ASSUME ALL OF THE RISKS OF PARTICIPATING AND/OR VOLUNTEERING IN EVENTS ORGANIZED BY THE Z CAR ASSOCIATION OF RICHMOND.

I acknowledge that participation in any activities involving motor vehicles carries a risk of injury or damage, and that by participating in such events; I expressly assume the risk of such injury, loss or damage.

I acknowledge that this Terms of Participation and Release of Liability form will be used by the organizers and/or sponsors of any ZCAR-related events in which I may participate, and that it will govern my actions and responsibilities at said events. In consideration of my application and permitting me to participate in ZCAR club events, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows:

- (A) **I WAIVE, RELEASE, AND DISCHARGE** from any and all liability, including but not limited to liability arising from the negligence or fault of the entities or persons released, for my death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to me including my traveling to and from ZCAR club events, **THE FOLLOWING ENTITIES OR PERSONS:** Z Car Association of Richmond and/or its directors, officers, employees, volunteers, representatives, and agents; the activity or event holders; activity or event sponsors; and activity or event volunteers.
- (B) **I INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE** the entities or persons mentioned in this paragraph from any and all liabilities or claims made as a result of participation in ZCAR club events, whether caused by the negligence of those released or otherwise. I acknowledge that Z Car Association of Richmond and its directors, officers, volunteers, representatives, and agents are NOT responsible for the errors, omissions, acts, or failures to act of any party or entity conducting a specific event or activity on behalf of ZCAR (Z Car Association of Richmond).

I acknowledge that ZCAR club events may involve a test of a person's physical and mental limits and may carry with it the potential for death, serious injury, and property loss. The risks may include, but are not limited to those caused by inertia, terrain, facilities, temperature, weather, condition of participants' equipment, vehicular traffic, actions of other people including, but not limited to participants, volunteers, spectators, coaches, event officials, and event monitors, and/or producers of the event, as well as to lack of hydration. These risks are not only inherent to participants, but are also present for volunteers.

I certify that I am physically fit, have sufficiently prepared or trained for participation in the ZCAR events in which I participate, and have not been advised to not participate by a qualified medical professional. I certify that there are no health-related reasons or problems which preclude my participation in these activities or events.

I hereby consent to receive medical treatment which may be deemed advisable in the event of injury, accident, and/or illness during ZCAR-related events.

I understand that at ZCAR events, I may be photographed. I agree to allow my photo, video, or film likeness to be used for any legitimate purpose by event holders, producers, sponsors, organizers, and assigns.

This Terms of Participation and Release of Liability form shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.

I CERTIFY THAT I HAVE READ THIS DOCUMENT, AND I FULLY UNDERSTAND ITS CONTENT. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT, AND I ASSENT TO IT OF MY OWN FREE WILL.
